## **How We Collect Information About You:**

E.T.C. & Candy Marcum Counseling staff collect data through a variety of means including but not necessarily limited to letters, phone calls, emails, voice mails, and from the submission of applications that is either required by law, or necessary to process inquiries, billing, and applications for licensure to state licensing agencies.

### What We Do Not Do With Your Information:

Information about your financial situation, mental health and or medical conditions and care that you provide to us in writing, via email, on the phone (including information left on voice mails), contained in or attached to applications, intake paperwork or directly or indirectly given to us, is held in strictest confidence.

We do not give out, exchange, barter, rent, sell, lend, or disseminate any information about applicants or clients who inquire for or actually receive our services that is considered patient confidential, is restricted by law, or has been specifically restricted by a patient/client in a signed HIPAA consent form.

#### How We Do Use Your Information:

Information is only used as is reasonably necessary to process billing or to provide you with health or counseling services which may require communication between and health care providers, insurance companies, and other providers necessary to: verify your information is accurate; determine the type of services you need including, but not limited to; or to obtain care outside of our standard of practice or care. Your non-medical information can be given to legal authorities including police, investigators, courts, and/or attorneys or other legal professionals, as well as any other information as permitted by law if there is a duty to report situation. Counselors in our practice may be required by law to report intentional acts, past acts against elderly, or children.

#### Information We Do Not Collect:

We do not use cookies on our website to collect date from our site visitors. We do not collect information about site visitors except for one hit counter on the main index page (<a href="www.candymarcum.com">www.candymarcum.com</a>) that simply records the number of visitors and no other data. We do use some affiliate programs that may or may not capture traffic date through our site. To avoid potential data capture that you visited a diabetes website simply do not click on any of our outside affiliate links.

Limited Right to Use Non-Identifying Personal Information From Biographies, Letters, Notes, and Other Sources: Any pictures, stories, letters, biographies, correspondence, or thank you notes sent to us become the exclusive property of E.T.C. & Psychotherapy, Inc and Candy Marcum Counseling. We reserve the right to use non-identifying information about our

clients (those who receive services or us) for promotional purposes that are directly related to our mission.

Clients will not be compensated for use of this information and no identifying information (photos, addresses, phone numbers, contact information, last names or uniquely identifiable names) will be used without client's express advance permission.

You may specifically request that NO information be used whatsoever for promotional purposes, but you must identify any requested restrictions in writing. We respect your right to privacy and assure you no identifying information or photos that you send to us will ever be publicly used without your direct or indirect consent

We are required by law to maintain the privacy and security of your protected health information ("PHI") and to provide you with this Notice of Privacy Practices ("Notice"). We must abide by the terms of this Notice, and E.T.C. & Psychotherapy, Inc and Candy Marcum Counseling must notify you if a breach of your unsecured PHI occurs. We can change the terms of this Notice, and such changes will apply to all information E.T.C. & Psychotherapy, Inc. and Candy Marcum Counseling has about you. The new Notice will be available upon request, in my office, and on our website. The website will always have the most recent version.

Except for the specific purposes set forth below, E.T.C. & Psychotherapy,Inc. and Candy Marcum Counseling will use and disclose your PHI only with your written authorization ("Authorization"). It is your right to revoke such Authorization at any time by giving us written notice of your revocation.

Uses (Inside Practice) and Disclosures (Outside Practice) Relating to Treatment, Payment, or Health Care Operations Do Not Require Your Written Consent. E.T.C. & Psychotherapy, Inc. and Candy Marcum Counseling can use and disclose your PHI without your Authorization for the following reasons:

1. For your treatment. E.T.C. & Psychotherapy, Inc. and Candy Marcum Counseling can use and disclose your PHI to treat you, which may include disclosing your PHI to another health care professional.

For example, if a physician or a psychiatrist is treating you, E.T.C. &

Psychotherapy, Inc. and Candy Marcum Counseling can disclose your PHI to him or her to help coordinate your care, although our preference is for you to give us an Authorization to do so.

2. To obtain payment for your treatment. E.T.C. & Psychotherapy, Inc. and Candy Marcum Counseling can use and disclose your PHI to bill and collect payment for the treatment and services provided by us to you.

For example, Candy Marcum Counseling might send your PHI to your insurance company to get paid for the health care services that E.T.C. & Psychotherapy, Inc. have provided to you, although my preference is for you to give us an Authorization to do so.

- 3. For health care operations. E.T.C. & Psychotherapy, Inc. and Candy Marcum Counseling can use and disclose your PHI for purposes of conducting health care operations pertaining to my practice, including contacting you when necessary. For example, E.T.C. & Psychotherapy, Inc. and Candy Marcum Counseling may need to disclose your PHI to my attorney to obtain advice about complying with applicable laws. Certain Uses and Disclosures Require Your Authorization.
- 1. Psychotherapy Notes. E.T.C. & Psychotherapy, Inc. and Candy Marcum Counseling do not keep "psychotherapy notes" as that term is defined in 45 CFR §164.501; rather, E.T.C. & Psychotherapy, Inc. and Candy Marcum Counseling keep a record of your treatment and you may request a copy of such record at any time, or you may request that E.T.C. & Psychotherapy, Inc. and Candy Marcum Counseling prepare a summary of your treatment. There may be reasonable, cost-based fees involved with copying the record or preparing the summary.
- 2. Marketing Purposes. As a licensed counselor, E.T.C. & Psychotherapy, Inc. and Candy Marcum Counseling will not use or disclose your PHI for marketing purposes. Marketing is defined as receiving financial remuneration for communicating about other businesses' health-related services or products to clients.
- 3. Sale of PHI. As a licensed counselor, E.T.C. & Psychotherapy, Inc. and Candy Marcum Counseling will not sell your PHI in the regular course of my business. Certain Uses and Disclosures Do Not Require Your

Authorization. Subject to certain limitations mandated by law, E.T.C. & Psychotherapy, Inc. and Candy Marcum Counseling can use and disclose your PHI without your Authorization for the following reasons:

- a. When state or federal law, and the use require disclosure or disclosure complies with and is limited to the relevant requirements of such law.
- b. For public health activities, including reporting suspected child, elder, or dependent adult abuse, or preventing or reducing a serious threat to anyone's health or safety.
- c. For health oversight activities, including audits and investigations.
- d. For judicial and administrative proceedings, including responding to a court or administrative order, although my preference is to obtain an Authorization from you before doing so.
- e. For law enforcement purposes, including reporting crimes occurring on my premises.
- f. To coroners or medical examiners, when such individuals are performing duties authorized by law.
- g. For research purposes, including studying and comparing the mental health of clients who received one form of therapy versus those who received another form of therapy for the same condition.
- h. Specialized government functions, including, ensuring the proper execution of military missions;
  - Protecting the President of the United States; conducting intelligence or counter-intelligence operations; or, helping to ensure the safety of those working within or housed in correctional institutions.
- i. For workers' compensation purposes. Although my preference is to obtain an Authorization from you, E.T.C. & Psychotherapy, Inc. and Candy Marcum Counseling may provide your PHI in order to comply with workers' compensation laws.
- j. Appointment reminders and health related benefits or services. E.T.C. & Psychotherapy, Inc. and Candy Marcum Counseling may use and disclose your PHI to contact you to remind you that you have an appointment with me. E.T.C. & Psychotherapy, Inc. and Candy Marcum Counseling may also use and disclose your PHI to tell you about treatment alternatives, or other health care services or benefits that E.T.C. & Psychotherapy, Inc. and Candy Marcum Counseling offer.

# E.T.C. & Psychotherapy, Inc.

Certain Uses and Disclosures Require You to Have the Opportunity to Object:

Disclosures to family, friends, or others. E.T.C. & Psychotherapy, Inc. and Candy Marcum Counseling may provide your PHI to a family member, friend, or other person that you indicate is involved in your care or the payment for your health care, unless you object in whole or in part. The opportunity to consent may be obtained retroactively in emergency situations.

## YOUR RIGHTS YOUR REGARDING YOUR PHI

You have the following rights with respect to your PHI:

- 1. The Right to Request Limits on Uses and Disclosures of Your PHI. You have the right to ask us not to use or disclose certain PHI for treatment, payment, or health care operations purposes.
- 2. E.T.C. & Psychotherapy, Inc. and Candy Marcum Counseling are not required to agree to your request, and I may say "no" if E.T.C. & Psychotherapy, Inc. and Candy Marcum Counseling believe it would affect your health care.
- 3. The Right to Request Restrictions for Out-of-Pocket Expenses Paid for In Full. You have the right to request restrictions on disclosures of your PHI to health plans for payment or healthcare operations purposes if the PHI pertains solely to a health care item or a health care service that you have paid for out-of-pocket in full.
- 4. The Right to Choose How E.T.C. & Psychotherapy, Inc. and Candy Marcum Counseling Send PHI to You. You have the right to ask us to contact you in a specific way (for example, home or office phone) or to send mail to a different address, and E.T.C. & Psychotherapy, Inc. and Candy Marcum Counseling will agree to all reasonable requests.
- 5. The Right to See and Get Copies of Your PHI. Other than "psychotherapy notes," you have the right to get an electronic or paper copy of your medical record and other information that E.T.C. & Psychotherapy, Inc. and Candy Marcum Counseling have about you. E.T.C. & Psychotherapy, Inc. and Candy Marcum Counseling will provide you with a copy of your record, or a summary of it, if you agree to receive a summary, within 30 days of receiving your written request, and E.T.C. & Psychotherapy, Inc.

- and Candy Marcum Counseling may charge a reasonable, cost based fee for doing so.
- 6. The Right to Get a List of the Disclosures E.T.C. & Psychotherapy, Inc. and Candy Marcum Counseling Have Made. You have the right to request a list of instances in which E.T.C. & Psychotherapy, Inc. and Candy Marcum Counseling have disclosed your PHI for purposes other than treatment, payment, or health care operations, or for which you provided us with an Authorization. E.T.C. & Psychotherapy, Inc. and Candy Marcum Counseling will respond to your request for an accounting of disclosures within 60 days of receiving your request. The list E.T.C. & Psychotherapy, Inc. and Candy Marcum Counseling will give you will include disclosures made in the last six years unless you request a shorter time. E.T.C. & Psychotherapy, Inc. and Candy Marcum Counseling will provide the list to you at no charge, but if you make more than one request in the same year, E.T.C. & Psychotherapy, Inc. and Candy Marcum Counseling will charge you a reasonable cost-based fee for each additional request.
- 7. The Right to Correct or Update Your PHI. If you believe that there is a mistake in your PHI, or that a piece of important information is missing from your PHI, you have the right to request that E.T.C. & Psychotherapy, Inc. and Candy Marcum Counseling correct the existing information or add the missing information. E.T.C. & Psychotherapy, Inc. and Candy Marcum Counseling may say "no" to your request, but E.T.C. & Psychotherapy, Inc. and Candy Marcum Counseling will tell you why in writing within 60 days of receiving your request.
- 8. The Right to Get a Paper or Electronic Copy of this Notice. You have the right get a paper copy of this Notice, and you have the right to get a copy of this notice by e-mail. And, even if you have agreed to receive this Notice via e-mail, you also have the right to request a paper copy of it.

HOW TO COMPLAIN ABOUT MY PRIVACY PRACTICES
